1. **Public Hearing**

The purpose of this public hearing is to review the Land Use By-Law amendments in relations to the separation distance regarding windmills.

f. **Capital Projects**

CAO Muise explained that there is money left over from a funding project for accessibility and staff is looking at using money to improve the accessibility in the Administration building. This project will be 50% funded by the capital reserve and 50% funded by the Government of Nova Scotia from the surplus of funds from the accessibility project. This project will include installing automatic openers for several doors and installing rails going down the hallways.

The other capital project that staff is seeking approval from Council is for the parking lot. This project would be funded 100% from the capital reserve. Staff has identified issues with flooding and accessibility in the parking lot that staff feels should be addressed as soon as possible.

Staff is seeking approval from Council to commence these projects.

It is MOVED by Councillor Glenn Diggdon and SECONDED by Councillor Ted Saulnier to approve the capital project requests for the Accessibility Upgrades to the Municipal Administration Building and the work on the municipal administration building parking lot.


