**f. Service Exchange**

Deputy Warden Nicole Albright asked questions regarding the road portion of this service exchange agreement. CAO Muise explained it in detail.

*It is MOVED by Councillor Kathy Bourque and SECONDED by Councillor Guy Surette to endorse all recommendations but one proposed by the Province of NS and NSFM as proposed in the shared services proposed agreement and encourage provincial approval at the fall sitting of legislature. Further, we will request additional clarity of purpose and application of the local road recommendations prior to endorsement.*

Councillor Guy Surette brought up the topic of mosquitoes for discussion. He has received multiple complaints from residents about mosquitoes. Understanding, there is no direct solution from the municipality, the council had a discussion about mosquitoes.




