1. **Call Meeting to Order**

Warden Danny Muise called the meeting to order at 6:31 p.m.

2. **Invitation to Stand and Move**

Warden Danny Muise reminded Council that they are permitted to stand and move as they need to during the meeting. This is a new initiative introduced by Argyle Recreation which normalizes movement in meetings.

4. **Presentation – Dan White, West Nova Chamber**

Dan White was present to speak on behalf of the West Nova Chamber. The West Nova Chamber took on the task of fighting for the Ferry to continue being in Digby. They are currently fighting to get the 101 highway completed. The West Nova Chamber is reaching out to partner with municipalities to work together on getting projects complete. They are looking to partner with municipalities to complete the Tourism and Trade Show for this part of the country next year. Dan highlights the importance of tourism in this area and how small areas should get educated and get the word out there about how beautiful this area is.

Councillor d'Entremont asked what area the West Nova Chamber of Commerce covers. Dan White indicated there is no restriction in NS of what part can join the West Nova Chamber.

Councillor Surette highlighted the importance of the Yarmouth Ferry.

Executive Assistant Newell gave council an overview of the changes to the Municipal Grants and Sponsorship Policy. The intent is to repeal Article C4 – Grants to Organizations, Article C34 – Fire Services Capital Grant Program, and Article C37 – Community Hall Grants policies in favour of the new policy. Council is asking to have clarification surrounding the Council Community Grants and what happens when they don't use all their money for their grants.

This is Council's 7-day notice for the passing of this policy.

It is MOVED by Councillor Glenn Diggdon and SECONDED by Councillor Ted Saulnier to allow \$4,200 per Councillor for the Council Community Grants with a cap of \$700 per organization per year.
