1. **Call Meeting to Order**

Deputy Warden Nicole Albright called the meeting to order at 6:35 p.m.

2. **Invitation to Stand and Move**

Deputy Warden Nicole Albright reminded Council that they are permitted to stand and move as they need to during the meeting. This is an initiative by Argyle Recreation which normalizes movement in meetings.

7. **For Decision and Discussion**

a. **Aquaculture Development Area Update and Information**

There have been quite a few questions, concerns, comments, and complaints. Many community members are now paying more attention since the announcement of this project. The ADA was a collaborative initiative, led by the province. The application process was incredibly long prior to the ADA, the Municipality would have no input on these applications before the ADA.

These sites are not pre-approved, they are pre-assessed. What the ADA means is that these sites have been assessed with certain criteria to note whether they are eligible.

The public can see these pre-assessed locations, but it must be noted these are not pre-approved.

The pre-assessed locations were selected by the province and 6 locations were released for applications from the province.

3 of the locations are not near any residential addresses, the other 3 have close residential addresses.

Deputy Warden Nicole Albright spoke on this subject, noting that residents feel their concerns were not heard. If these sites are applied for a public engagement period will open, the province will send out letters to residents who are near these sites. One on ones will be had with residents at their request on their concerns. There is still a chance for the public to have their say. This is a pilot project, and we are learning as we go.

CAO Muise advises that councillors can set up their one-on-one appointments with support from staff. Preferably held at the Municipal Building in Tusket, this is beneficial as any resources needed are easily accessible.

Warden Danny Muise feels there is perception that the Municipality is in charge of this, any concerns will be forwarded to the province, but our part is done.

CAO Alain Muise states we are not responsible for the decisions, we can help residents by hearing and voicing their concerns on these 6 sites. The remaining 47 on the map are pre-selected with no lease. We can be more influential on these sites. This gives us plenty of time to vet these locations appropriately.

These are leases of a location, not a license. A license gives the opportunity to fish anywhere, a lease is specific to one location.

The application process through the ADA still takes approximately 2 years. This is not an instant process.




