

ARTICLE 18 – GROUP INSURANCE, MEDICAL PLAN

- 18.01 All Employees who qualify shall be required to participate in the group insurance medical plan.
- 18.02 The cost sharing of this plan shall be divided equally between the Municipality and the Employees.
- 18.03 The Employee's contribution shall be collected on a regular basis by way of payroll deduction.
- 18.04 Employees will pay 100% of the cost of long term disability group insurance premiums. (Effective April 24, 1993)

ARTICLE 18 – GROUP INSURANCE, MEDICAL PLAN
