During our visit to Yarmouth in January to share the results of the Yarmouth Area Cancer Services Review, we committed to striking a joint Nova Scotia Health Authority / Department of Health and Wellness (NSHA/DHW) Steering Committee to guide our work to enhance access to cancer care for Yarmouth area residents.

I am inviting you (councilors from Yarmouth and area municipalities) to identify one representative from your municipalities who would be interested in joining us a member of the Steering Committee to help guide this work.

Your main role would be to provide oversight and advice to working groups whose members will research various options/approaches to ease the burden on residents who need specialty cancer services in Halifax. Working groups will report back to the Steering Committee.

Our first meeting will be an in-person meeting in Yarmouth for all who are available. The meeting will be held at the Yarmouth Regional Hospital on March 11<sup>th</sup> from 2 p.m. - 4 p.m. Those who cannot attend in person will be able to join via Skype.

The frequency and length of meetings will be among the items for discussion at the first meeting. We will share a draft project charter, prior to the first meeting, for review and discussion.

Please let me know if you have a representatives who is interested in helping us guide this important piece of work forward. Meeting details and an agenda will follow.
