## **Business Arising from the Minutes**

Dangerous or Unsightly Policy

CAO Muise shared with Council the amendments to the policy. He highlighted some of the changes that were made since the last meeting. The TLC relief, which is the grant, is not available for any cleanup done prior to September 30, 2019. The loan is available to any cleanup regardless of date. CAO Muise added a transitional period to the policy which outlines any outstanding balances for property cleanup performed prior to September 30, 2019. These properties will only be entitled to a TLC Relief grant if they are a qualified property and the work was completed based on a dangerous property clean up paid for by the Municipality. It was reinforced by CAO Muise that the loan is a one time offer for those properties deemed unsightly. It was recommended by Council that dates and deadlines be added for staff and property owners to see a change in the property in a timely manner.

Council would like to defer approval of the policy to a future meeting. CAO to bring policy to legal council and Provincial partners.
