#### **Presentations**

### Sonia Smith - Clean NS

Sonia Spoke about the Home Warming program. The program has been running since 2015. Funded by Province and NS Power. Applicants have to own the home, not renting. Applicants must meet income thresholds. Home Warming Program is only available for one home, one time.

## Rebecca Rose – Community Navigator

Rebecca spoke about recruitment, retention and the community navigation piece of her role. She tracks medical students that are currently in our area and who might be looking into residency in our area. Rebecca is currently working on development of Credit Union place that will house medical students. Recruitment piece is on-going. Navigation piece deals with housing, explaining local customs, schools and many other things. Five new additions of physicians since she started her position. The shortage previously was 6 family medicine doctors and 4 anesthesiologists. Currently we have 1 vacancy for an anesthesiologist and 3 vacancies for physicians. Some medical residents choose to stay where they are doing their residency.

## **Business Arising from the Minutes**

Unsightly Vessel in Wedgeport

Councillor LeBlanc highlighted the history of the vessel. Boat owner cannot afford to remove it but landowner wants it removed. Staff will need permission/consent from boat owner to remove the vessel. Concern about the storage of the vessel.

It is moved by Roderick Murphy Jr. and seconded by Lucien LeBlanc that Council approve the cost of removing the vessel to a maximum of \$1500.

Councillor Diggdon refrained from voting due to a conflict of interest

#### For Decision

### Structural Reform-Consolidation

CAO Muise highlighted some points of the document.

Municipality of Argyle is currently financially viable. Population in Argyle is aging and declining. We do need structural reform. Concerns and fears heard from public consists of: increased taxes, consolidation would benefit the Town only and losing our sense of identity in Argyle. Must consider what happens to Argyle if the other two partners decide to consolidate.

Councillor Donaldson explained that he is hearing from the public that they are not interested/ready in consolidation.

Warden Muise expressed his concerns about consolidation and the fears from the public. He is not convinced that consolidation is the way to go.

Councillor Diggdon feels he has not had enough information to make a decision and cannot vote for consolidation.

Councillor Bourque agrees with other councillors. Work needs to be done on regional agreements.

Councillor Albright expressed concerns about how we are doing things and what is best for us right now. Does not feel ready for consolidation.

Councillor LeBlanc expressed concerns with the issues Argyle is currently experiencing that consolidation might fix. He feels consolidation is not the right option right now, but something needs to be done to address the issues.

Deputy Warden Surette expressed concerns about the timeline that Province set out. Discussion about regional agreements. CAO Muise highlighted how the partnerships work and how frustrating they are from an administrative perspective.

It is moved by Kathy Bourque and seconded by Glenn Diggdon that Council notify the Town of Yarmouth, the Municipality of Yarmouth and Municipal Affairs that the Municipality of Argyle is not ready to consolidate at this time.

Motion Carried (8 in favour, 0 against)

## Water lending program/PACE Efficiency Program

Deputy Warden Surette briefly described the history of the program. He also highlighted the PACE program. An explanation was given on the request for decision. Councillor LeBlanc expressed his frustration with the program and thinks it is just a band-aid solution to the larger problem.

It is moved by Richard Donaldson and seconded by Lucien Leblanc that the water lending policy be extended to an indefinite time, allowing up to \$240,000 in lending to our residents, and that staff amend policy to reflect this decision.

## CAO Muise highlighted the PACE program.

It is moved by Glenn Diggdon and seconded by Danny Muise that the CAO or his designate lead the research on renewable energy and energy efficiency projects available to Nova Scotians, and that a report be brought to Council recommending projects with the best potential to assist us and our residents.
