The meeting was called to order at 6:30 pm by Deputy Warden Nicole Albright.

On a motion by Guy Surette and seconded by Danny Muise the agenda was approved as circulated.

Conflict of Interest Declaration

Deputy Warden Nicole Albright asked for any declarations of conflict of interest from the floor.

None declared.

Presentation - Darryl LeBlanc, West Pubnico Golf Course

Darryl LeBlanc spoke to Council about the West Pubnico Golf Association. Darryl is looking into the possibility of a partnership with the Municipality of Argyle. The key points to his presentation were:

- Financially, the golf course is doing well, especially since they have switched to an Association.
- There are capital costs that are going to be coming up in the next 5-10 years.
- A clubhouse is going to need to have major repairs, as it was purchased over 20 years ago and has not had any major renovations or repairs done to it since.
- Equipment is going to need to be purchased.
- The Golf Association does not feel that financially, they will be able to purchase new equipment and do major repairs to a clubhouse.
- The Golf Association would like some sort of commitment from Council it does not have to be this year.
- They feel they are able to take care of the operating expenses and the wages of employees.
- They have not replaced equipment in over 7 years, including tractors and mowers, as they have been well maintained.
- Darryl indicates the Association feels they have a major asset in the Municipality of Argyle, indicating they have one of the largest recreational facilities in the Municipality.

- The Association is willing to offer their recreational facility to the Muncipality and the Recreation Department. Darryl indicated they could use the facilities in the winter and summer for certain activities such as hikes on the golf course, snow shoeing, cross country skiing, clubhouse for yoga classes, for seniors games nights, teen activities in exchange for commitment of annual funding from the Municipality to go towards capital projects.
- Darryl mentioned there is \$20,000 set aside in their budget for the loan they received from the Government. The Government just extended the deadline for total payment of this loan to the end of 2023. They plan to set aside \$20,000 this year in the budget as well to pay the total of the \$40,000 loan.

Councillor Surette mentioned the \$40,000 loan. He indicated that he heard there was \$10,000 forgivable on that loan. Darryl mentioned the loan was increased to \$60,000 and \$20,000 was forgivable. He indicated they have \$20,000 put aside for the loan right now, and planned on paying it off by the deadline this year. However, the deadline was extended to the end of 2023, so they will put aside \$10,000 this year and \$10,000 next year.

Warden Muise asked if the Association has looked into grants for the federal and provincial government for capital projects and repairs. Darryl said they have looked into these grants. The purpose of his presentation tonight was the put the Golf Association on Council's radar. They will also be attempting fundraising. The problem they run into with fundraising is having volunteers wanting to help out with volunteering.

Councillor Saulnier asked if their membership was down. Darryl indicated yes, they have 168 memberships total for the last few years.

Deputy Warden Albright stated that Council will put this on their radar.

West Pubnico Lift Station Pumps

Councillor Saulnier asked how many pumps there are and is wondering if they can be refurbished in any way. His concern is that one pump costs over \$10,000.

Acting Chief Administrative Officer Boudreau mentioned that these pumps are an asset and they need to be well maintained. Once they break, they are more than likely to be at the end of life.

Financial Report

Director of Finance, Marsha d'Eon reviewed the financial report for the end of December 2021 as attached to the agenda.

Some key things she pointed out to Council were:

- The Deed Transfer Tax is at \$173,354 over the prorated budget number.
- The Provincial Government unconditional transfer is at \$116,189 over the prorated budget This is the Municipal Finance Capacity Grant otherwise known as the Equalization grant. This is the platform commitment made by the new government to double this grant until the new memorandum of understanding was negotiated.
- These 2 line items alone make up \$289,343 of the surplus.
