Despite the many challenges over the past ten years, your DMO has helped increase awareness and interest in Yarmouth & Acadian shores as a travel destination. YASTA delivers valuable work and has helped increase visitation and related sector spending. Municipal and private sector partnerships have ensured that the essential and ongoing work of destination marketing, event attraction, and business development has contributed to the region's economic growth.

As destinations compete for more visitors, YASTA must explore more ways to drive business to operators and increase visitation. To that end, YASTA requests that our municipal partners review and accept the following report, <u>Driving</u> <u>Destination Competitiveness - Accommodation Levy for Yarmouth County.</u>

Additionally, to ensure long-term destination competitiveness, the board of YASTA requests the Town of Yarmouth, The Municipality of the District of Yarmouth, and The Municipality of the District of Argyle, in accordance with The Municipal Government Act, Bill 204 (as passed), enact equivalent by-laws that impose a marketing levy on persons buying short-term accommodation in their respective municipalities, and

- (a) Set levy rates of 3% of the total purchase price of the accommodation.
- (b) Grant levy funds collected to the Yarmouth & Acadian Shores Tourism Association to promote regional tourism.
- (c) Agree that levy funds directed to YASTA are in addition to municipal core funding granted to YASTA.
- (d) Develop an inter-municipal agreement between YASTA municipal partners to ensure that each municipality understand their role in the YASTA partnership.
