Seeing as there were two nominations, ballots were distributed, and votes were cast.

It is MOVED by Councillor Nicole Albright and SECONDED by Councillor Gordon Boudreau to close nominations.

It is announced that Councillor Ted Saulnier is elected Deputy Warden for the Municipality of the District of Argyle.

Councillor Nicole Albright was sworn in as Warden of the Municipality of the District of Argyle.

Councillor Ted Saulnier was sworn in as Deputy Warden of the Municipality of the District of Argyle.

Warden Nicole Albright and Deputy Warden Ted Saulnier both gave a short speech of gratitude to Councillors and the residents for their confidence in their leadership.

It is MOVED by Councillor Kathy Bourque and SECONDED by Councillor Glenn Diggdon to destroy the ballots.
