Re: **Amendments to the Municipal Planning Strategy**

In Accordance with Policies 6-4 and 6-5 of the Municipality of the District of Yarmouth's Municipal Planning Strategy, I am advising you that Council is considering amendments to the Municipal Planning Strategy that would affect lands within 500 meters of your municipality. The purpose of the proposed amendments is to bring policies into alignment with provincial amendments to the Statements of Provincial Interest regarding Wind Turbine Generator Policies, as presented in the Wind Energy Public Participation Report Final. Following the Public Hearing Municipal Council may hold second reading of this proposed amendment.
