RE: Recommendation to Council of Demolition

In the best interest of the safety of our community and the fire and life safety issues involved at a property at 1057 Hwy 335, I am requesting the process to commence for demolition. The purpose of this request is to conclude this 5-year-old file.

We received a complaint for this building on June 23, 2025 for roof shingles flying off the building and hitting the complainants truck next door repeatedly. The complainant is also very concerned for the fire and life safety of their home as it is directly next door to their property.

This building has been an issue dating back to April of 2021. Our former By-Law Enforcement Officer Hans Pfeil was also involved and has a lengthy detailed file that will be included with the Council Package.

I have been involved with this ongoing issue since June of 2022. There have been clean-ups, hazardous material cleanups, boarding up and partial building collapses along with severe forced entry. There is also a broken well which has filled a partial basement area with water. Many pics will be in the council Package. There is a very <a href="heavy fire load">heavy fire load</a> within this building as pictures will show. In all issues dating back to April of 2021, the owner never responds to phone messages, emails, warning letters and order letters. His only response is to pay the bills involved when it is applied as a tax lien.

I am requesting the process of demolition to commence as soon as possible in the interest of public safety.

I have reviewed along with the CAO the policies and MGA regulations for Dangerous or Unsightly premises and the rules associated with this action.

# **NOTES TO FILE**

June 30, 2022 – Site visit keeping an eye on the building. Noticed partial building collapse of rear entry way and tall brush up against the building with excess debris on one side. Sent letter. No response. Duffus Remove All cleaned up. Applied as tax lien. Taxes paid.

July 7, 2022 – Site Visit – 70 barrels of dogfish in formaldehyde behind the building are very close to the ocean. Contacted Glenn Diggdon for help finding owner. Owner contacted and barrels removed.

June 16, 2025 – Site visit keeping an eye on the building. I noticed someone ripped open the back outside wall and created a large hole and gained entry. I also noticed someone tried to kick in a piece of plywood covering a side entry door.

June 23, 2025 – Received complaint about shingles coming off of the building at 1057 Hwy 335 and going on to his property and hitting his truck. He stated he is very concerned about a Fire and Life Safety issue as the building is directly next door.

July 8, 2025 – Warning letter sent registered for the condition of the property. Letter returned August 13, 2025

August 18, 2025 - The the owner of the building does not return phone messages. Email used in the past does not go through anymore stating that his email box is too full. Registered letter sent on July 7, 2025, has been returned on August 13, 2025

August 20, 2025 – Order to Remedy letter sent registered for the condition of the property. Letter returned September 19, 2025, Phone calls, text messages and emails also sent with no response.

I am contacting you at this time regarding the condition of your property at the above noted address. We are receiving complaints about your property at 1057 Highway 335 in Middle West Pubnico N.S. I have been to the site and took pictures. There is a partial building collapse in the rear corner of the building and must be torn down and resecure the building. There is also a lot of debris and oil tank on the south side of the building which must be cleaned up. This building may need to be demolished which will require a permit.

In its present condition and from pictorial accounts this property is deemed dangerous and unsightly based on definitions (r) in the Municipal Government Act (MGA) and our Municipal Policy. You are required to contact us immediately as this condition has been an issue since our last letter to you of May 21, 2022.

The Municipality reserves the right to take further legal action should the situation warrant such action(s).

I am contacting you at this time regarding the condition of your property at the above noted address. An official complaint has been filed with this office as to the condition of this property and the dangers it has. We did a site visit after the building was recently discovered to be severely damaged in the rear of the structure. Someone created two large holes in the rear of the building and gained entry. They also tried to break in the plywood over the side entry. Pictures were taken inside and out. This property is now deemed "Dangerous and Unsightly", as defined in Part XV of the Municipal Government Act (MGA) and our Municipal Policies. This building has extremely deteriorated over the years and needs to be demolished. Letters have been written and sent all the way back to May of 2021. We are giving you 7 days of the receipt of this letter to respond to this office before an "Order" is written. The "Order" will give you 30 days to remedy the situation. If no response has been received, this building will be brought before The Municipal Council and recommended to be demolished. Any and all costs incurred by the Municipality to remedy the situation will be recovered as a first lien pursuant to Section 507 of the MGA.

Please be advised that the above noted property has been determined to be "Dangerous and Unsightly" as defined in Part XV of the Municipal Government Act (MGA) and you are hereby ordered to remedy the situation on your property. There has been an official complaint filed with the office due to its deterioration of roof shingles flying off and hitting automobiles. There has been a serious break in at the rear of the building creating two large holes to gain entry and an attempt to kick in the plywood covering a ride side entry door. The siding has deteriorated and is falling off creating holes. One wall on the right side is seriously sagging and could

This building is also a Fire and Life Safety issue due to its very close proximity to the neighbor. A registered written warning letter was sent to your registered address and returned to this office. This is the last step before this issue is brought forth to the Municipal Council and the demolishment of this building will be recommended.

You have **14 days** after service of this order to contact this office to notify us of your intentions to remedy this very serious situation. Please contact this office at 902-648-2623 to advise this office of your plans to fulfill this order. Failure to comply with this order will result in action from the Municipality of Argyle in accordance with section 346 of the MGA. Any and all costs incurred by the Municipality to remedy this situation will be recovered as a first lien pursuant to section 507 of the MGA. As in Section 346 (2) MGA you may appeal this order to Council within seven days upon posting. Your appeal may be brought forwarded to:





















# Civic# 1057 HWY 335, Midl. West Pubnico, Yarmouth County, Nova Scotia

April 8, 2021

H.Pfeil was contacted by Councillor Diggdon with concerns about the safety of the remaining building on the property. The "Old Hall" building raised concerns to residents after the fire of the fish plant.

April 13, 2021

H. Pfeil performed a site visit and assessed the building and property. The building is showing severe signs of deterioration and is not secured. Access to the inside is not blocked. It was deemed dangerous and unsightly.

April 15, 2021

Opening letter was sent out via mail with 7-day deadline.

April 22, 2021

No response.

May 7, 2021

Letter came back unopened; email was sent by H.Pfeil with a copy of the letter attached with a time line of another 7 days to respond to MODA.

May 14, 2021

No response to the letter or email. Order of Remedy to secure the building is being prepared.

May 17, 2021

Order to Remedy was posted on the property.




